Most significant gains


- OHRLLS exceeded the requirements for two indicators and met the requirements for another nine indicators.
- Notably in 2023, OHRLLS newly met the requirements for Policy and Capacity Assessment indicators.

Areas for improvement

• UN Women encourages OHRLLS to focus on the two indicators missing requirements: Strategic Planning and Financial Resource Allocation and the three indicators currently approaching requirements.

PERCENTAGE OF RATINGS MEETING/EXCEEDING REQUIREMENTS (NOT APPLICABLE RATINGS OMITTED)




In 2018, OHRLSS trailed the average performance of the UN Secretariat and the overall UN System.

COMPARISON OF RATINGS WITHIN THE UN SYSTEM, 2023



In 2023, OHRLLS "exceeded" fewer indicators than similar entities and the overall UN System, and rated more indicators as "missing" requirements. However, the entity assessed more indicators applicable.

COMPARISON OF RATINGS BY YEAR, ENTITY SPECIFIC, 2018-2023



From 2018 to 2023, OHRLLS achieved solid progress by "meeting" a significantly greater proportion of indicators, and assessing more indicators applicable.

In 2023, OHRLLS improved upon its 2022 performance by shifting two indicators from "approaching" to "meeting" requirements, though one indicator reverted to "approaching" requirements.
