Organizational matters

Institutional budget estimates for 2012-2013

Under this item, the Executive Board will have before it the institutional budget estimates for the United Nations Entity for Gender Equality and the Empowerment of Women (UN-Women) for 2012-2013 (UNW/2011/11).

The proposal is driven by the strategic plan, 2011-2013 (UNW/2011/9), which was endorsed by the Executive Board in its decision 2011/3, as well as the strategic framework for the period 2012-2013, which the Committee for Programme and Coordination recommended for approval by the General Assembly subject to the modifications outlined in the report on its fifty-first session (A/66/16). Building on the support budget for the biennium 2010-2011, the institutional budget estimates for 2012-2013 aim to strengthen the capacity of UN-Women to deliver the results outlined in the strategic plan and the strategic framework, with an emphasis on providing enhanced support in the field.

The Executive Board may wish to approve the institutional budget estimates for 2012-2013.

The comments of the Advisory Committee on Administrative and Budgetary Questions on the institutional budget estimates for 2012-2013 are contained in document UNW/2011/12.
